



# 2010 MUNICIPAL PARKING RAMP REGULATIONS

North Ramp means the public parking ramp north of W. 49 1/2 Street and west of Edina Realty

Middle Ramp means the public parking ramp south of W. 49 1/2 Street behind TCF

South Ramp means the public parking ramp north of W. 51st Street and east of Lund's

**DESIGNATED PERMIT PARKING AREAS:**

The following places are designated employee parking areas:

1. The top uncovered level of the South Ramp.
2. The "Permit Parking Only" (lower level) of the South Ramp.
3. The southerly portion of the top covered level of the South Ramp.  
(Please observe signs on this level for permit parking areas)
4. All spaces designated for 5 hour parking in the North Ramp.

**EMPLOYEE PARKING:** Employees may park in designated areas for longer than the posted hourly restrictions after they have purchased and display a current parking permit issued by the City of Edina.

**HOURS OF ENFORCEMENT:** Posted hourly restrictions are enforced between 8 A.M. and 6 P.M. except Sunday. No overnight parking.

**DISABLED PARKING:** Employees that have a State Disabled Permit or Disabled License Plates are not required to purchase a parking permit. Disabled persons may park in any public parking space when the disabled permit or license plates are displayed.

**PARKING PERMIT REGULATIONS AND APPLICATION:**

1. A PARKING PERMIT WILL BE ISSUED ONLY TO A PERSON REGULARLY EMPLOYED ON A FULL-TIME OR PART-TIME BASIS IN A BUSINESS LOCATED ON THE EDINA SIDE OF THE 50TH AND FRANCE COMMERCIAL AREA.
2. Parking permits are \$48.00 per year, prorated at \$4.00 per month. Permits are valid until April 15, of the following year.
3. Permits must be affixed to the LEFT REAR BUMPER and MUST BE EASILY VISIBLE FROM THE DRIVE AISLE BY THE PARKING MONITOR WHEN THE VEHICLE IS PARKED. The bumper must be clean, warm and dry for the permit to adhere properly. **NOTE:** The permit will not adhere to rubber. If the bumper is rubber covered, the permit may be placed above the left rear bumper. Permit may be placed on left corner of rear window. If tinted glass, permit must be affixed to exterior of window.
4. PARKING PERMITS ARE VALID ONLY FOR THE VEHICLE LISTED ON THE APPLICATION. If an employee drives more than one car to work, s/he may purchase two permits for the price of one PROVIDED proof of ownership is furnished for each vehicle at time of purchase. When a vehicle is sold or traded, a new permit will be issued for no charge if 50% of the old permit, including the number is submitted with a new application. Lost or misplaced permits will not be replaced, a new permit will have to be purchased.
5. When a person ceases to be a regular employee in the Edina 50th and France Commercial Area their permit will be canceled. A prorated refund of \$4.00 per month is available when at least 50% of the permit with the number is returned.
6. A PARKING PERMIT DOES NOT GUARANTEE OR RESERVE A SPACE.
7. SECTION 1400.10 of the City Code provides that any vehicle moved a distance of less than 3/10<sup>th</sup> of a mile during the parking period shall be deemed to have remained stationary.
